## INTERNATIONAL BUSINESS SCHOLARSHIP IN HONOURS

### Conditions of Award

1. Established in 2007 and funded by the Discipline of International Business, The Faculty of Economics and Business. The title of the scholarship is 'International Business Scholarship in Honours'.
2. The Scholarship is intended to promote excellence in research study in the discipline of International Business.
3. The scholarship is valued at \$6,000, tenable during the recipient's undergraduate honours year. Up to five scholarships will be allocated each year and the Discipline of International Business may award as full or half value scholarships.
4. Awarded annually to candidates commencing Honours IV in International Business, the recipient must be completing their honours year in one year of full-time study. The scholarships are open to local and International students.
5. The recipient is selected by a panel of academics from the Discipline of International Business. Selection is based on proficient performance in coursework, examination results and formal application requiring presentation of a research proposal of sufficiently high standard with supporting methodology and literature.
6. Full scholarship may not be awarded to students in receipt of other scholarship funding specifically awarded for the student's honours year or scholarship funding of primary, equal or higher value without renouncing that award.
7. The scholarship holder is liable to return the funding in full if they withdraw from their honours year.
8. The scholarship is administered by the Faculty of Economics and Business.
