Conditions of Award 2010

1. Established in 2006 by an annual donation from CVC Limited. The title of the award is 'The CVC Scholarship for International Entrepreneurship Research'.
2. The Scholarship is intended to promote excellence in international entrepreneurship research and advance qualitative research strategies and methodologies.
3. The scholarship is valued at \$10,000 and tenable for one year. An amount of \$5,000 will be paid at the commencement of each semester of the recipient's Honours Year.
4. Awarded annually to a candidate commencing an undergraduate Honours year in International Business, the recipient must be completing their honours year in one year of full-time study.
5. The recipient is selected by a panel of academics from the Faculty of Economics and Business. It is awarded on the basis of most proficient performance in coursework, examination results and by formal application with a thesis proposal focusing on innovation, commercialization and rapid growth. Commencing 2008, selection will also include specific reference to performance in the unit of study "IBUS 3103 - Global Entrepreneurship & Enterprise".
6. The Scholarship Holder will meet with their Supervisor and a representative from CVC, prior to commencing the thesis to discuss the topic. Additional meetings will take place mid year to check progress and then on completion of the thesis.
7. The scholarship may not be awarded to a student who is in receipt of other funding specifically awarded for the student's honours year or in receipt of a scholarship of equal or higher value without renouncing that award.
8. The scholarship holder is liable to return the funding in full if they withdraw from their honours year.
9. The scholarship is administered by the Faculty of Economics and Business.
