Graduate Destination Report 2008

FACULTY OF ECONOMICS AND BUSINESS

This report was compiled using data from the 2008 Australian Graduate Survey which captures information on the destination of University of Sydney graduates approximately four to six months after they complete their final year of study. This report can be used to give an indication of the numerous directions that graduates take after completing their undergraduate degree. While the AGS obtains information about the start of graduates' career paths, it does not provide information on where they eventually find themselves in terms of life-long professions and objectives. Please note that completion of the AGS is voluntary and the statistics do not represent the entire body of students graduating for that year (the response rate is approximately 50% of all University of Sydney graduates in the given year).

- A total of 1293 Economics and Business graduates participated in the 2008 survey
- Within 4-6 months after graduation, most graduates were working in **the private sector (75%)** versus the public sector (22%)
- **88% of graduates found employment within Australia.** Of those working overseas, 51% were working in China
- Over a third of students completing undergraduate study (37%) and 16% of students completing postgraduate study indicated they would study further
- **73%** of all graduates **were employed** at the time of the survey
- 80% of all students completing undergraduate study, who were available for fulltime work, were working fulltime
- 63% of postgraduates who were available for fulltime work, were working fulltime
- Of those graduates working fulltime, **76% were satisfied with their job** and were not seeking a new role
- The average gross annual salary for the faculty was **\$46,793** (r=819)
- Students who completed undergraduate study reported earning an average gross annual salary of \$39,572 (r=334). Graduates who completed post-graduate study reported earning an average gross annual salary of \$52,494 (r=10). Honours graduates reported earning an average gross annual salary of \$46,373 (r=62)
- Graduates relied on a range of methods to locate their new employment. **26% of graduates found work via family or friends.** A further 22% relied on internet advertisements, and 9% relied on the university or careers services

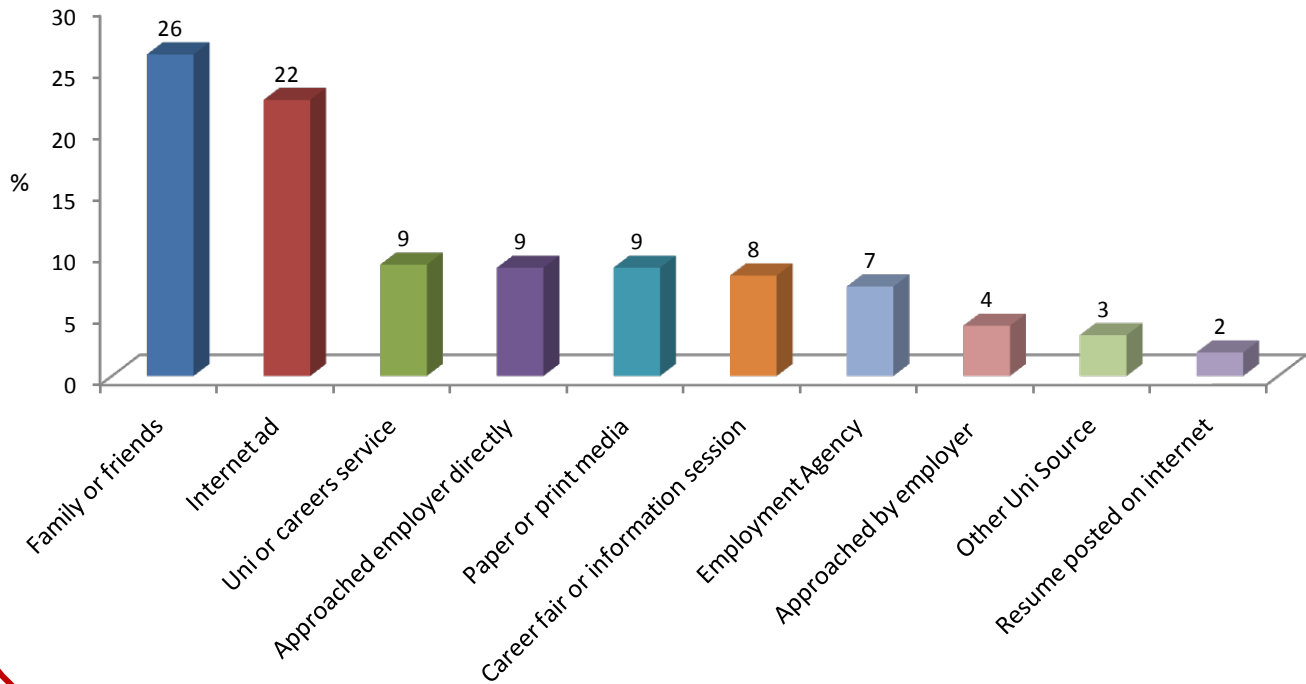

Method Used to Locate Current Employment



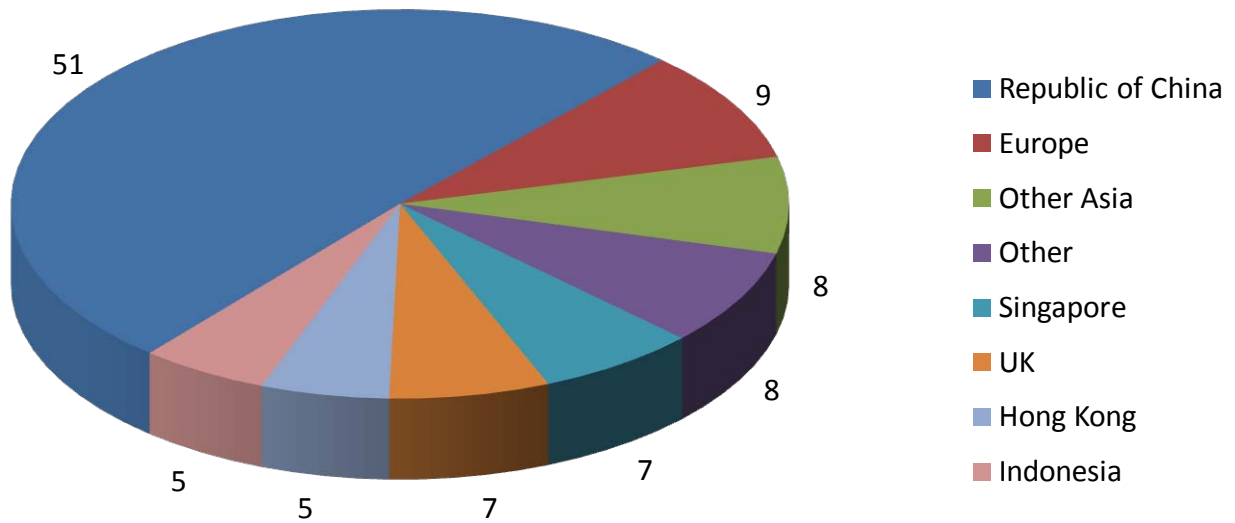
Location of Employment
